

Christ Church St Ives Terms & Conditions for Camps 2022

1. Cancellations made between 31-60 days before the commencement of camp will incur a cancellation cost of 75%. Cancellations made within 30 days of camp, not due to medical reasons, will incur a cancellation fee of 100% of the camp fee. Unless we are able to find a replacement attendee when waiting lists are in operation, in which case a \$25 admin fee will be charged.
2. Cancellations made prior to 24 hours to the start of camp due to ill health reasons (including Covid19 or contraction of Covid19 by a member of your household) will incur a \$25 administration fee. A medical certificate or NSW Covid Test Registration will be required as proof of illness.
3. Cancellations made within 24 hours of commencement of camp due to ill health reasons (including Covid19 or contraction of Covid19 by a member of your household) will incur the cost of a 24 hour period of camp costs. A medical certificate of NSW Covid Test registration will be required as proof of illness. Where possible, we will endeavour to reduce costs incurred.
4. Full refunds are available if NSW Government Health regulations prevent the camp from proceeding.
5. Partial refunds are available if your child is required to be sent home during the camp due to exhibiting potential COVID symptoms, such as fever, cough and/or sore throat. This refund will be calculated in 24 hour increments from commencement of the camp.
6. By registering a person, I agree to him/her participating in all supervised activities.
7. I acknowledge there is an inherent risk within activities undertaken as part of the camp. In the event of an accident or illness, and where it is impracticable to communicate with me (the student's parent or guardian), I authorise the Camp Director to consent to the student receiving any medical or surgical treatment as may be deemed necessary by a licensed physician and/or surgeon. I authorise the Camp Director to engage in such treatment and I agree to pay the appropriate fees for such service and treatment.
8. I agree to meet the expense of the registered person being returned home if I am unable to collect him/her personally, including any costs for Children's, Youth and Families Staff or leaders to accompany him/her home and then rejoin the group. I understand that such an arrangement may be necessary due to illness, injury, or if, in the opinion of the Children's, Youth and Families Staff, the student exhibits non-cooperation or anti-social behaviour of any description, or inability to meet the rigours and requirements of the camp activities. The Children's, Youth and Families Staff will make every reasonable effort to communicate with me concerning any such behaviour or circumstances.
9. By registering myself/ my child/children, I agree to all Christ Church Camp Covid Policy.(insert link)
10. By registering a person/child on this Christ Church camp, I agree to the use of any photos or video footage of the student in accordance with the Christ Church St Ives Social Contact Policy, including any permissions given or refused.

11. All registrations require payment of the full amount to be confirmed. Early bird discounts only apply when full payment is received on registration.
